- 200 Yd **5 Shot Groups** --- Four 5 Shot Groups (20 Record Shots Total)  
--- 200 Yd **10 Shot Groups** --- Two 10 Shot Groups (20 Record Shots Total)  
**AND Score** - Same Record Targets used for both Groups & Score

There will be only **ONE RELAY**.

- 100 Yd **Offhand** ----- Two 10 Shot Strings (20 Record Shots Total)  
Offhand is optional, not included in Aggregates.

Targets : 100 Yds MR-31 and at 200 Yds MR-52 (Offhand Target --- TQ-4)

Entry Fee --- \$30 (This includes the \$15 per day Range Fee)
